Holly Sitch – Discharge Coordinator

We have had an extremely busy 5 and ½ months this fiscal year with 245 clients being assisted home to date. The West region had 127, Central had 27 and the East had 83 clients. We have had 8 requests from other locations provincially as well.

Due to the number of discharges out of Kenora DJ over the last month, we requested and received permission to move our Sioux Lookout SUV to Kenora as one driver in that community is not enough. We are now in the process of hiring a second driver for Kenora to help offset the cost of the use of taxis to transport our clients. We are also recruiting a new driver in Timmins as there is a vacancy for this position also.

With such positive team, who are dedicated to make sure everyone can get home as quickly and as safely as possible, I see only success for the program.

Talking Together Program—Aboriginal Alternative Dispute Resolution



Carol Buswa is a member of the Long Lake #58 First Nation and is the Talking Together Program Manager for Nishnawbe Aski Legal Services in Thunder Bay. Carol attended Lakehead University and earned a Bachelor of Arts degree and Bachelor of Education degree. She also attended; Principals of First Nation Schools Six Nations Polytechnic Institute; and is an Associate Member of The Ontario Association for Family Mediation.

Carol has lived and worked in Northern Ontario for the last 35 years, working extensively with Aboriginal children, families, and communities, as an educator, administrator, and facilitator. She currently manages the Talking Together Program and received training in Family Mediation, Introduction to Child Protection Mediation, Family Group Decision Making, Advanced Family Mediation & Domestic Violence. She has also re-

ceived a Level 1 Certificate in Trauma Counselling for Front Line Workers through Gail Appel Institute-a division of the Hicks-Dellcrest Centre and Child Welfare Training. Carol has conducted several ADR Circles as a facilitator and does presentations within the Nishnawbe Aski Nation territory and throughout northern Ontario.

As a lead in forward development of the AADR-bill 210 (Aboriginal Alternative Dispute Resolution) strategy for Nishnawbe Aski Legal Services Corporation, and responsible for managing the Talking Together Program She works with five Facilitators and one Assistant-Coordinator. The Program has developed many partnerships and community networks within the 49 First Nations of the Nishnawbe Aski Nation as well as off reserve communities. Talking Together also provides AADR service to First Nation communities in the North Bay area through a special project with Community Counselling of North Bay (2014) and continues today. Since covid19 the TTP staff and program have adapted to change and uses more technology in providing service to its clients.

Currently, we are working on a new project My Journey Back Home specifically targeting youth aging out of the child welfare system. “My Journey Back Home” project is in process of providing an Alternative Dispute Resolution Facilitator and Aftercare Worker specifically for youth facing crisis, violence, human-trafficking, homelessness, drug addiction, mental health, lack of education, legal issues, lack of life skills, basic needs and who have lost their path in the life cycle journey.

The project target is for youth ages 16-29 encompassing ADR Circle support services of My Journey Back Home project. The facilitator will take on referrals and do an intake and follow up with client within 24-48 hours. The project will target Indigenous youth and those transitioning out of the Child Welfare System. The Facilitator would provide an Alternative Dispute Resolution process ‘Talking Together’ a traditional ADR Circle approach. This model would allow youth, to make decisions, share, speak freely, and be acknowledged in a respectful traditional and safe manner but most importantly empower and build on strengths, skills, cultural care, and resiliency. The project would give the opportunity for the youth and their participants to experience a holistic approach with their supporting participants and family at the Circle, including an elder of their choosing. We look forward to working with our youth and organizations in the Thunder Bay area.

Overall, I have enjoyed my journey with Nishnawbe Aski Legal Services and look forward to continued progress within the organization in the best interests of community and our people. Miigwech.

I am a Talking Together Facilitator for the Talking Together Program. I have been working with Nishnawbe-Aski Legal Services Corporation since 2013. The ultimate goal is for the participants to come together to have an open discussion surrounding the concerns from both parties (family and agency). Every situation is unique because each family needs are different. I am honoured to work and listen with the family and participants involved in the circle in their decision making. All the decisions come from the participants involved.

I am the Talking Together Facilitator for Timmins and Area. I service Timmins, Beaver House, Chapleau, Flying Post, Matachewan, Mattagami, Missanabie Cree, Taykwa Tagamou and Wahgoshig. I started with Nishnawbe Aski Legal Services Talking Together program the year of 2020. I am originally from Moosonee, Ontario and relocated to Timmins, Ontario in '2001'.

Talking Together is a restorative approach for dealing with child welfare issues. The goal of Talking Together is to bring participants together to discuss family problems in a non-judgemental way. The Circle is composed of family members, front line workers, agency representatives, community elders and Band Council representatives. In the Circle, participants look at whos been affected and how they have been affected by the problems that the family is experiencing. Secondly, in the Circle , participants are asked: What can be done? If and when an agreement is reached, it is used as the basis for the plan of care.

Being able to work within this program is a blessing. I am very thankful to be employed with Nishnawbe Aski Legal Services.

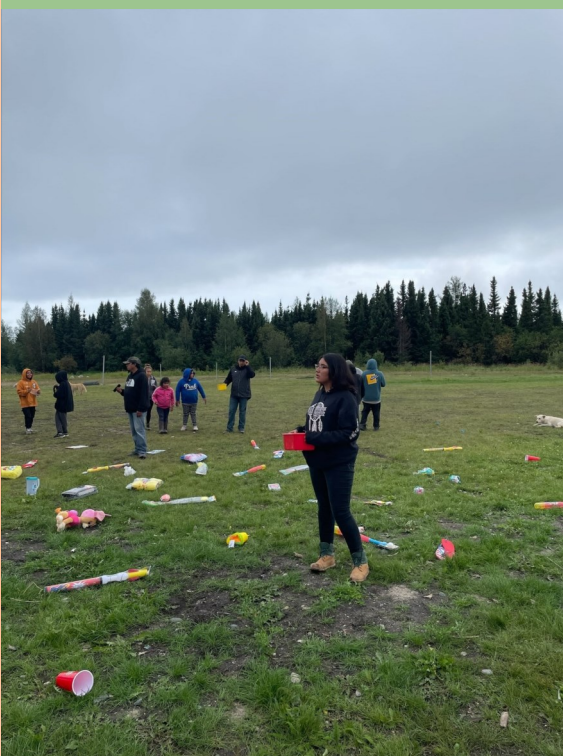

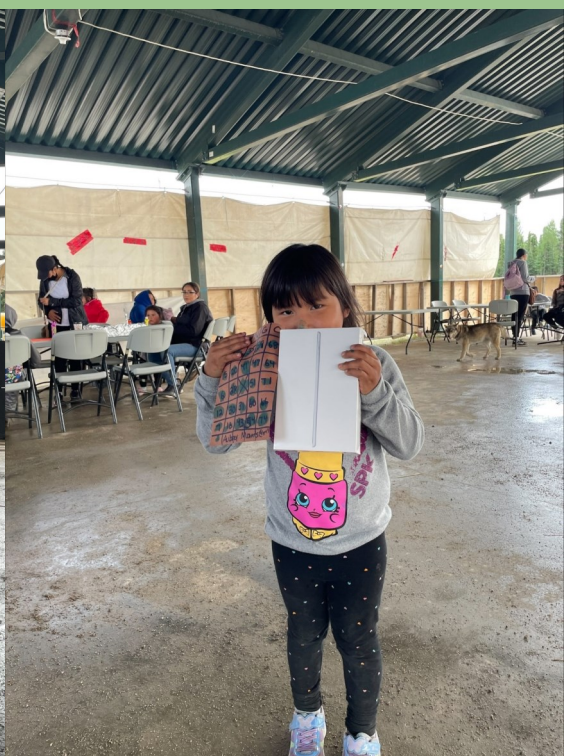
