# Legal Aid Information

## LEGAL AID

Nishnawbe Aski Legal Services Corporation's Legal Aid Program can issue Legal Aid Certificates for NAN community members/ clients, residing in the NAN territory, who qualify under the Legal Aid Ontario's Financial and legal eligibility guidelines (see chart below)

NALSC assist in certain legal matter's which include Criminal Law (if custody is probable), Youth Criminal Justice Act, Family, Child Welfare, and some Administrative Law.

Legal Aid does not cover civil law, employment lawyer, human rights, housing, and social assistance. NAN members can contact NALSC Community Legal Worker to apply for Legal Aid in person, on Advance Day or Court Day. Persons can also contact our office and speak to an Legal Assessment Officer to apply.

### WHAT DO “DUTY COUNSEL” DO?

Duty Counsel is a lawyer who works for Legal Aid Ontario who can provide general legal advice in the areas of criminal, family and immigration law.

A Duty Counsel lawyer is not someone's lawyer, but they can assist with various stages of the criminal process for individuals who don't already have a lawyer or who choose to represent themselves in court. There will always be a Duty Counsel lawyer in court, and you can ask to speak to them if you have questions about your charges. You do not need to be eligible for Legal Aid to speak to Duty Counsel. However, if you already have a lawyer representing you, you will need to speak to your lawyer, not Duty Counsel.

### WHAT ARE ADVANCE DAYS?

Advance Days are sessions on zoom, that are scheduled one day before Court in Northern communities. The Crown, Duty Counsel, Community Legal Workers, Restorative Justice workers, accused persons, and sometimes other Lawyers will attend “Advance Day” to discuss matters on the docket, for court the next day. Advance Days are like a “dress rehearsal” before court so that everyone knows what will happen in court. It provides an opportunity for different parties to update each other on how matters are progressing. Ultimately, this helps court run more smoothly and efficiently.

# Information on Criminal Matters

## WHAT TO DO IF YOU ARE ARRESTED FOR A CRIMINAL OFFENCE

If you are arrested for a criminal offence, it is important to stay calm and to comply with the instructions given to you by police. Failure to do so may result in additional charges. Once you are arrested, police will have two choices depending on the circumstances: they can release you with conditions, or they can keep you in jail (detention).

If you are released, it is important to keep the documents given to you by police in a safe place and to follow the conditions you have been given. Your documents will also include your next court date, and it is important that you attend your court date either in person or virtually, depending on how courts are proceeding in your area. Your documents will have more details on court location if you are asked to attend in person, or they will have more information on how to log on or call in to court if you are asked to attend virtually.

If you are detained, you have a right to speak to a lawyer under the Canadian Charter of Rights and Freedoms. Until you have spoken to a lawyer, it is best not to say anything to police as what you say may be used against you in court. You will have a court appearance as soon as possible after you have been arrested, usually on the day following your arrest. There, the Crown and a Justice of the Peace will decide if you can be released with appropriate conditions. If you are released, you will be given a next court date with instructions on how to attend court, as well as your release conditions. If you are not released, you will continue to be detained until your next court appearance.

If you have been charged with a criminal offence, and would like more information on what to do next, please contact NAN Legal's Main Line (807-622-1413) and ask to speak to a criminal lawyer. You can ask to speak to Duty Counsel on your court date to determine next steps.

## WHAT TO DO IF THIS IS YOUR FIRST CRIMINAL OFFENCE

If this is your first offence, and depending on your offences, you may be eligible for Diversion. Diversion is an alternative stream to the criminal justice system, which allows you to complete programming and / or a Restorative Justice circle along with agreements, so that your charges can be withdrawn. Successful completion of a Diversion program means that you will not receive a criminal record for the charge(s) that were diverted. Not all offences are eligible for diversion, and this will depend on the severity of the situation. You will also need to take responsibility for your actions and be prepared to repair harm.

# Information on Bail

If you are arrested for a criminal offence and police decide to keep you in jail (detention), you have a right not to be detained without just cause. This means that you have a right to a bail hearing as soon as possible for a Justice of the Peace to determine if you can be released with appropriate conditions.

It is important for you to find a lawyer to represent you for your bail hearing so that you can determine a bail plan to secure your release. If you are eligible for Legal Aid, you can find a lawyer to represent you for your bail hearing once you have your Legal Aid certificate. Please speak to your Community Legal Worker about applying for Legal Aid.

A bail plan will usually involve a set of conditions that you need to be prepared to follow, and that will be related to the circumstance of your offence to prevent future offences from being committed. These conditions can include asking you to reside at a particular location, not contacting an individual involved in the offences you are charged with, not possessing weapons, not consuming alcohol (some exceptions can be requested), etc.

For more serious charges, you may also need a **SURETY** as part of your bail plan, which is someone who is willing to supervise you while you are released, and who is also responsible for making sure you attend your court appearances to deal with your charges.

## RECORD SUSPENSION (“PARDON”)

If you have a Criminal Record due to convictions for criminal offences that happened a long time ago, you may be eligible for a RECORD SUSPENSION (previously known as a “pardon”). Record suspensions are administered by the Parole Board of Canada (PBC).

As of January 1st 2022, the fee to apply for a record suspension has been reduced to \$50.

*\*Note that there may be other expenses to gather all documents required for your application.*

# What is a Surety?

A surety is a person who promises the court to supervise an accused person, while they are released on bail. A surety will be named in the accused person's release papers and pledges or promises an amount of money to the court by signing the release order. This amount of money will only be collected if there is a breach. A breach occurs if the accused person does not follow one or more of the bail conditions. A separate court process will be required to obtain the money. This is not automatic and will depend on a number of factors, including whether the surety was complicit in the breach.

## TO BECOME A SURETY, THE FOLLOWING CRITERIA MUST APPLY TO YOU:

- Be over the age of 18
- Be a Canadian citizen or a landed immigrant
- Ability to sign a release order
- Not be involved in the offence the person has been charged with
- Not have any outstanding criminal charges
- Not have a criminal record
- Ability to monitor the accused to make sure they are complying with the conditions of their release
- Willingness to report a breach should it occur
- Ability to pledge sufficient money as a pledge to the court in case there is a breach

## THE RESPONSIBILITIES OF A SURETY INVOLVE:

- Making sure the accused person attends court as required
- Making sure the accused person follows the bail conditions of their release (e.g. if they have a "no contact" condition with a given individual, the surety would also need to make sure they do not contact that individual, etc.)
- Monitoring the accused person could require any of the following:
- Calling them regularly
- Visiting them regularly
- Living with them (most common)
- Calling the police if the accused does not follow any of the bail conditions
- Being prepared to lose the money that has been pledged in the event of a breach (This would involve a separate court process, and will also depend on whether the surety

was complicit in the breach).

## IF YOU DO NOT WISH TO BE A SURETY ANYMORE, YOU HAVE TWO OPTIONS:

1. You can bring the accused person to court personally and ask to be relieved of your responsibilities as surety. This will result in the accused person being taken to jail.
2. You can apply to the court in writing to be relieved of your duties. The court will issue an order for the arrest of the accused person.

# Meet our Legal Aid Staff



## **DON RUSNAK** **MANAGER OF LEGAL SERVICES**

Don Rusnak is a lawyer and politician who served as the Member of Parliament (MP) for the riding of Thunder Bay-Rainy River in the House of Commons of Canada from 2015 to 2019 as a member of the Liberal Party of Canada. Born and raised in Northwestern Ontario, Don has deep roots and has lived, worked and learned in the North for most of his life. He studied Political Science and Integrated Forest Resource Management at Lakehead University. In 2001, he attended the University of Manitoba, Robson Hall Faculty of Law, and during his final year, attended Osgoode Hall Law School to study in the Intensive Program in Aboriginal Lands, Resources and Governments.

Don has extensive professional experience drawing from his work in the forestry industry, the public sector, and from his own legal practice. While working with Manitoba Health, Don helped to improve the delivery of healthcare services for Northern Manitobans, and as a Crown Prosecutor in Eastern Alberta, he prosecuted criminal and regulatory offences for the Province of Alberta. Don served as the interim Executive Director for Grand Council Treaty # 3 in Kenora, where he helped restructure the organization. Prior to entering politics he operated a small but successful law firm based on the Fort William First Nation.

Over the years Don has volunteered his time with many organizations, such as the Ontario Justice Education Network, Thunder Bay Community Foundation, Thunder Bay Law Association, TBRHSC Research and Ethics Board and the Martin Aboriginal Education Initiative.

In 2015, Don was elected to represent the riding of Thunder Bay-Rainy River in the federal election, defeating the incumbent Member of Parliament. He was the only First Nation Member of Parliament elected in the province of Ontario and served as the first ever chair of the Liberal Indigenous Caucus.


In September 2017, Don was appointed as Parliamentary Secretary to the Minister of Indigenous Services. While in Parliament Don served on Standing Committee on Indigenous and Northern Affairs, Standing Joint Committee of the Library of Parliament and Director-at-Large Canada-Ukraine Parliamentary Friendship Group. In 2019 Don left politics in order to spend more time with his young and growing family.

Today, Don resides in Thunder Bay with his wife and their 4 young children.

## **HEATHER BAILLIE LEGAL AID COORDINATOR**

Heather Baillie is the Legal Aid Coordinator for Nishnawbe-Aski Legal Services. She has been with NALSC since 1993, working from the Thunder Bay office. As coordinator, Heather oversees the daily operations of the legal aid department.
