To date, I have been employed with Nishnawbe-Aski Legal Services for over 17 years in the Restorative Justice Program.

As the Restorative Justice Manager, I am responsible for running and expanding the vast Restorative Justice Program's under my umbrella. NALSC's Restorative Justice Program was created in 1996, to deliver Restorative Justice to the 49 First Nation communities in the Nishnawbe Aski Nation Territory. Our current Restorative Justice Program portfolio includes Restorative Justice, Youth Justice, Pre-Charge Restorative Justice, By Law Restorative Justice, Sexual Assault & Domestic Violence Restorative Justice, PARS Program, Youth Intervention & Prevention, Guns & Gangs Initiative, and the Community HUB Programs.

Let me tell you, It has been an amazing 17 years! I have gotten to see the program expand and grow, when we first started we had only 3 Restorative Justice Workers and to date our current program is over 25 workers. I have also seen how beneficial and needed these programs are to the NAN communities we service. Each of our programs are designed to work hand in hand and complement each other. In 2019, I started to work for Nishnawbe-Aski Legal Service Corporation (NALSC) in the Restorative Justice By-Law Program for the central region. At the end of June 2020, I started a new role in the Restorative Justice Sexual Assault/Domestic Violence (RJ SADV) Program. This program provides services for all Nishnawbe-Aski Nation communities.

At the beginning of 2022, we were fortunate to have a Restorative Justice Youth SADV Worker to strength this program. Melanie Mohan started with NALSC as a Victim Witness Worker in August 2019 and then joined our RJ SADV Program this year. She brings a wealth of knowledge and experience to help shape and expand this program. Melanie and her husband live in Timmins, ON and have two boys.

Throughout the time of Covid, it became more apparent that there was a need for programming and/or educational resources for clientele that have domestic related offences. At the time of the development of this program, we incorporated the Duluth Model as a key component of this Indigenous Intimate Partner Violence Prevention Program (Ministry approved). Our key focus for this program is about planting educational seeds as an opportunity to provide change and healing.

Going forward, Melanie and I are in the process of developing the Restorative Justice Sexual Assault training manual. We will utilize and incorporate some of the training received from the Community Justice Initiative program. As we continue to grow and develop this program, we are always learning and expanding our knowledge.

Our main goal is to help break cycles of violence and abuse, by planting one seed at a time. It has been a world wind of progress and change; we look forward to the continuous growth of this program.

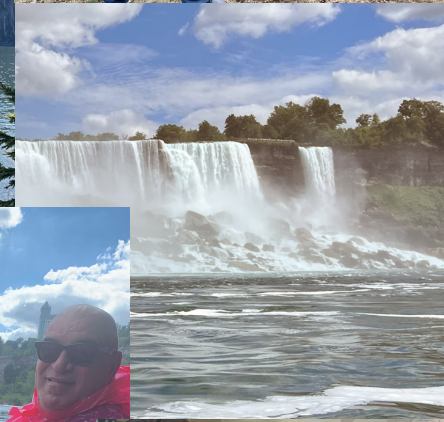
I am a member of the Muskrat Dam First Nation and in my work capacity as Restorative Justice Bylaw worker I will be covering the NAN West catchment area of First Nation Tribal Councils and Independent communities. In an outreach capacity I will also work with other communities in the NAN territory as assigned.

The primary purpose of the Bylaw program is to give support to NAN First Nation communities which are developing and establishing their own community bylaw programs that may include indigenous cultural values and practices. We are aware that some First Nation communities already have a program in place and can use the NAN Legal Bylaw program to further enhance their efforts in addressing issues such as abuse of intoxicants, street drugs, underage drinking and other community social ills that are not necessarily law related. The Restorative Justice component of the bylaw program can be used to resolve disputes and as a tool to enforce community bylaws. Matters affecting the community would not necessarily have to appear in a court of law for resolution. Diversions from local law enforcement agencies (NAPS and O.P.P) and visiting courts can be accessed and processed before a formal charge can be laid by utilizing the Restorative Justice component of the Bylaw program.

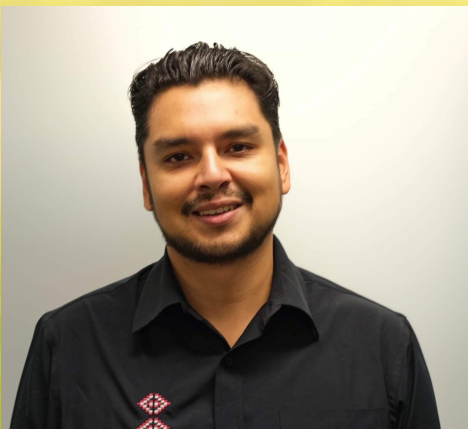

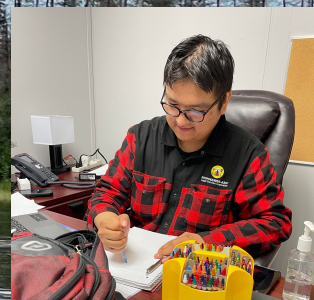

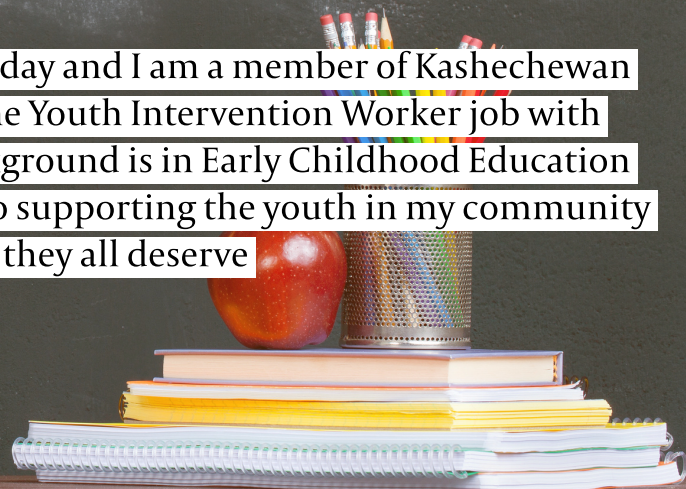


# SHEILA FRIDAY

## KEN SACKANEY

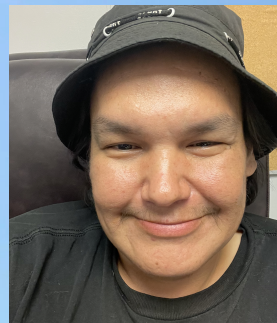
**Restorative Justice Worker,

The name is Ken; my band is Constance Lake First Nation, but my family originated from Fort Albany. I've been with NAN Legal for 5 years starting out as a part-time youth intervention worker. Eventually going full time with dual roles with restorative justice in Fort Albany.

My focus in Fort Albany was prevention. My role was to provide the youth with engaging activities in a structured environment, as it was beneficial for their growth. The main activity was basketball. Focusing on discipline, hard work, and dedication would achieve results. The basketball teams won numerous regional tournaments in the James Bay, Quebec Cree First Nations, and with our proudest moment being the girl's high school team qualifying for Ontario Federation of School Athletic Association. Other activities included providing workshops for multimedia arts and partnering with local organizations to do full community events.

I took the role of restorative justice for a personal reason. When I was 19, I was accused of shoplifting in Sudbury. The court experience was traumatizing, and I was initially upset that I was wrongfully accused. I knew the consequences of having a criminal record for my future employment. I had to hire a lawyer; the fees were a financial burden as I was not educated about legal aid. My case resulted in a diversion program like Restorative Justice. This experience inspired me to become a restorative justice facilitator. I started in Fort Albany and eventually assisting the neighbouring James Bay communities.

In 2021, I needed a change of scenery within the organization. I transferred to Thunder Bay to broaden my horizons, where I am now servicing the Matawa communities. I am looking forward to meeting more communities, establishing new strategies to improve services to members of Matawa.



## RYAN SAKAKEEP

**Restorative Justice - Pre-Charge  
Worker**

My name is Ryan Sakakeep, I am from Kitchenuhmaykoosib Inninuwug currently residing in Thunder Bay.

I am a pre charge worker looking after Matawa Communities and I also look after Restorative Justice and Pre Charge in my home community. I started with NAN Legal Services on July 12, 2022 and I am enjoying my work and getting to know my fellow employees. I was previously with NAN as one of the original Youth Intervention Workers back in March 2007. I was with the corporation for 7 and a half years before I got elected to council. I worked in education, health, pandemic, helped with NAN Legal from time to time before I took some time off to look after my mental health. Then here I am back at NALSC, full circle.

As a pre charge worker, I am responsible for holding circles with offenders to help repair the damage caused by their offences, rather than get charges laid and go through the court process. It is at the discretion of the NAPS officer who received the call to make the referral to NAN Legal Pre Charge Program. Activities can include counselling, letters of apology, restitution, community service, cultural activities, hunting and fishing, and helping at sporting events.

Community service does not have to always be manual labor, it can be fun and creative. My only restriction is community service cannot be performed anywhere when someone makes monetary profit such as stores or places of business.

Once a referral is completed, I will be in contact with the person involved and set up a time and date for a circle, either in person or on zoom. Then we will all come up with an agreement and we would keep in contact until everything is finished. This is an alternative to being charged with an offence and going through court, as we all know it has been a challenge due to travel restrictions due to the pandemic.

I look forward to working with you from now until April 2022







## Mary Spencer, Youth RJ Worker

Aanii my name is Mary Spencer and I am a member of the Chippewas of Nawash First Nation. I started working for NALSC in 2016 as a Youth Intervention worker while I was living in Kashechewan. My role soon expanded to include Restorative Justice in Kashechewan and I thoroughly enjoyed both positions. I used my experience as a 2012 Olympian in boxing to teach the youth in Kashechewan how to box and to use their skills in a good way. In 2019 I was inspired to continue my journey as a boxing athlete and took a leave from NALSC to pursue a professional career. During the Covid-19 pandemic in 2020, I was invited to continue my work with NALSC using online platforms. I was thrilled to continue working with the community of Kashechewan and as pandemic restrictions were lifted, I was even able to accompany two groups of youth from Kashechewan to boxing training camps in Montreal, Quebec. Today I serve as a part-time Restorative Justice worker for Kashechewan and I look forward to assisting with youth programming in the future.
